

Deposit Account Application Form

Members now can lodge to a Deposit balance: this is a separate balance to your existing Shares balance or a credit union Current Account balance. The maximum balance permitted cumulatively across individual members' Shares, Deposits and Current Account Balances is \notin 100,000. This is a regulatory limit and no exceptions can apply, any lodgements which would bring combined balances above \notin 100,000 will be rejected.

There is no Life Savings Insurance on Deposits.

Currently no interest is applied on Deposit balances. Interest rates, however, can be changed by the Board of Directors at any time.

Members will be able to lodge to Deposit accounts, via Direct Debits, Standing Orders, Credit Transfers, Payroll Deduction, or at the counter.
